Gillespie Field Development Council Requirements: Members must have expertise and experience in such fields as real estate, finance, industrial development, aviation, or other fields related to the development program for Gillespie Field and have a demonstrated interest in the economic viability of the Field. According to the Agreement between the County and City (Resolution No. 104-74), three members are appointed by the Board of Supervisors and are ratified by the City Council. Two members are appointed by the City Council and ratified by the Board of Supervisors. Members file Statements of Economic Interest (Form 700) with the Clerk of the Board of Supervisors.

Public Safety Facilities Financing Oversight Committee Requirements: According to Section 2.24.910 of the El Cajon Municipal Code, the Public Safety Facility Oversight Committee shall consist of seven members, no less than four members who are residents of the city at the time of applying for the commission and who shall continue to reside in the city during their term of office. Conflict of Interest Code: Committee members are required to file a Form 700 according to provisions of the Political Reform Act, the Fair Political Practices Commission, and the City's Conflict of Interest Code.

Veterans' Commission Requirements:

*1 member appointed by the City Council is active service or reservist with the U.S. Armed Forces and a resident of El Cajon.

**3 members appointed by the City Council that have been honorably discharged from the U.S. Armed Forces; two must be residents and one is permitted to be a resident or non-resident. All three members must also be active members of a City of El Cajon based 501(c)19 veterans' organization.

*** 1 member appointed by the City Council must be a resident of El Cajon and have been honorably discharged from the U.S. Armed Forces, but does NOT need to be a member of a 501(c)19 veterans' organization based in El Cajon.

Members of the Veterans' Commission are required to file a Form 700 according to provisions of the Political Reform Act, the Fair Political Practices Commission, and the City's Conflict of Interest Code.
