Amendment to FY 2019-2020 ONE YEAR ACTION PLAN

The City is proposing an amendment to the 2019-2020 One Year Action Plan and the allocation and commitment of Community Development Block Grant (CDBG-CV) funds from the U.S. Department of Housing and Urban Development. Approximately \$802,656 in CDBG-CV funds has been identified as available due to the Coronavirus Aid, Relief, and Economic Security Act signed into law on March 27, 2020. These funds must be used to prevent, prepare for and respond to the coronavirus. The public review and comment period has been reduced in order to quickly distribute the funds into the community. HUD has granted the City of El Cajon a waiver allowing for this reduction in public review and comment period. A public hearing will be held on **Tuesday, May 12, 2020 at 3:00 P.M. in the El Cajon Council Chambers at 200 Civic Center Way, El Cajon, CA 92020**.
